ANNEXE 1 – MANDATORY CONDITIONS

Designated Premises Supervisors

No supply of alcohol may be made under the premises licence – (a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Personal Licence Holders

Every retail sale or supply of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence

Irresponsible Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free Tap Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Smaller Measures

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify
- the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Exhibition of Films

No film shall be exhibited unless it has received a "U", "PG", "12A", "15" or "18" Certificate from the British Board of Film Classification ("BBFC"). Admission of children must be restricted in accordance with the Certificate provided by the BBFC.

Notwithstanding the above-mentioned provision, a film may be exhibited and children may be admitted thereto if the permission of the Licensing Authority is first obtained and any recommendations of such permission are complied with.

If the Licensing Authority does not agree with the category in which any film passed by the BBFC is placed, it shall be at liberty to alter such category and on notice of such alteration being given by the Licensing Authority to the holder of this certificate, the film thereafter shall be treated as having been placed in the altered category and the condition applicable to the exhibition of films in such altered category shall be complied with.

Sale of Alcohol below the cost of duty plus VAT

- (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- (2) For the purposes of the condition set out in paragraph 1-
- (a) 'duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979(6)
- (b) 'permitted price' is the price found by applying the formula -

P=D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of sale or supply of the alcohol,
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol.
- (c) 'Relevant person' means, in relation to premises in respect of which there is in force a premises licence-
- (i) The holder of the premises licence
- (ii) The designated premises supervisor (if any) in respect of such a licence, or
- (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence
- (d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question.
- (e) 'value added tax' means value added tax charged in accordance with the Value Added Tax Act 1994(7).
- (3) Where the permitted price given by Paragraph (b) of paragraph 2

would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ('the first day') would be different from the permitted price on the next day ('the second day') as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

ANNEXE 3 - OPERATING SCHEDULE & AGREED CONDITIONS

Note – Some conditions may apply to one or more of the objectives

Crime and Disorder

- 1. The sale or supply of alcohol under the authority of this premise licence shall be only made to persons attending private pre booked events or organised pre-arranged events.
- 2. When the function room operates under the authority of the premise licence a personal licence holder shall be present except in an emergency.
- 3. Preston Police Licensing Unit shall be notified 14 days in advance of any occasion that the function room is to operate under the authority of the premise licence. If this is not possible due to a short notice Hall booking, such notification will be given as soon as that booking has been confirmed. This notification will include the name and contact details of the person booking or organising the event, the nature of the event and the intended operating hours for the event.
- 4. Persons under the age of 16 years shall not be permitted to remain in the function room after 21.00 unless accompanied by an adult and attending pre booked private function or organised pre-arranged events.
- 5. Only glasses that are made of toughened glass (when available) shall be used on the premise.

- 6. Only person aged 18 years or over shall sell or supply alcohol.
- 7. The premise shall have in place a written check 21 policy. This policy shall be actively promoted and state that any person to which the sale or supply of alcohol is being made, who looks or appears to be under 21 years of age shall be asked to provide identification that they are 18 years of age or over. The following are the only forms of identification acceptable:
- a) Passport
- b) Photo driving licence
- c) Pass accredited holographic proof of age card
- d) Any other form of identification agreed with Preston Police Licensing Unit.

Signs promoting this policy shall be prominently displayed at the entrance and alcohol sales / supply areas.

- 8. Notices shall be displayed at the exits to the premise asking customers to leave the premises and area quietly and to have consideration for residents.
- 9. Doors and windows will be kept closed during regulated entertainment except for access/egress.
- 10. Capacity restricted to 200 Persons in the Large Hall and 50 Persons in the Small Hall
